Motion Of Loa Bliss, As Trustee, Etc., For Extension Of Time Re Disclosure Of Experts: Granted

City of Ventura has now consented to the motion on condition that new expert Jordan Kear's report be served by December 15, 2021 with the City given until January 18, 2022 (Jan. 17 being a public holiday) to provide its own Supplemental Disclosure in response thereto.

Motion of Casitas Municipal Water District ("Casitas MWD") Motion To Serve Untimely Expert Witness Disclosures: Granted

The expert whom this party wants to designate, Jordan Kear, has already been designated by a similarly situated cross-defendant (City of Ojai), and no additional opening disclosure is contemplated by Casitas MWD. If now co-designated by this party, this expert will have a right to make a Supplemental Declaration specific to the interests of this party whereas he previously would only have been retained to advance the interests of a similarly situated, but not identically situated, cross-defendant. This does not amount to any material prejudice to City of Ventura. (The Court is applying a "prejudice" standard whether this is seen to be controlled by C.C.P. § 843 or C.C.P. § 2034.720.) That additional factual information will be provided to the Court via expert testimony is not "prejudice," even if it requires City of Ventura and its counsel to do more work. The same is true even if the expert testimony provided for the benefit of Casitas MWD happens to tip the scales in Casitas' favor at time of trial.

The Court does believe that the current deadline for presentation of Supplemental Reports by Kear and any other disclosed expert should remain December 3, 2021, not December 10, 2021. The Court would propose that the newly set deadline for Rebuttal Experts be January 10, 2021 except as to issues relating to the Upper Ojai Basin. As to that subject, the Court would propose a February 1, 2022 deadline, following the City of Ventura's January 18, 2022 Supplemental Disclosure deadline.
