I, Marnie A. Prock, declare and state as follows:

1. I am over the age of eighteen years and a senior paralegal employed by the law firm of Best Best & Krieger LLP (“BBK”), attorneys of record for Respondent and Cross-Complainant, City of Buenaventura (“CITY”) in the above-entitled action (“Action”).

2. I have been a paralegal in California for more than 21 years and have held various positions in two of California’s largest and most historic public law firms for more than 31 years. I have been employed by BBK since September, 2010. Each of the facts stated herein is within my personal knowledge, and I would so testify if called as a witness at any hearing.

3. On April 27, 2021 in response to the Judge’s April 19, 2021 order to set an Order to Show Cause hearing regarding the 51 unserved Cross-Defendants behind gated and fenced properties, I prepared notices and acknowledgments of receipt along with a full service package which included the following documents:

- i) Summons;
- ii) Third Amended Cross-Complaint;
- iii) Notice of Adjudication – English; Notice of Adjudication – Spanish;
- iv) Form Answer approved for use by Cross-Defendants;
- v) ADR Package;
- vi) Channelkeeper Complaint;
- vii) City Answer to Channelkeeper Complaint;
- viii) State Board Answer to Channelkeeper Complaint;
- ix) Notice of OSC Hearing re Publication;
- x) Ex Parte Application for Order for Publication and supporting documents; and
- xi) A self-addressed, stamped envelope for the Notices and Acknowledgment of Receipt to be returned in.

1 4. On April 28, 2021 overnight mailing packages were prepared upon my supervision
2 and direction for each of the 51 unserved Cross-Defendants and picked up for delivery by UPS.
3 A true and correct copy of the names and addresses of the 51 unserved Cross-Defendants is
4 attached hereto and incorporated herewith as Exhibit A.

5 5. On April 29, 2021, I received via UPS tracking emails, the attached proof of
6 delivery on 49 of the 51 unserved Cross-Defendants. True and correct copies of the proofs of
7 delivery receipts from UPS for each of the 49 unserved Cross-Defendants are attached hereto and
8 incorporated herewith as Exhibit B.

9 6. On April 29, 2021, I received an undeliverable mailing notification from UPS that
10 Darren and Lisa Lisle's address was undeliverable. True and correct copies of the proof of
11 undeliverable receipts from UPS for Darren and Lisa Lisle are attached hereto and incorporated
12 herewith as Exhibit C.

13 7. On April 30, 2021, a duplicate mailing of the April 28, 2021 packages were sent
14 via USPS overnight mail to the PO Box address from both a TLO report and Ventura County
15 Assessor records on file for the Lisles. A true and correct copy of the tracking information for
16 each package to the Lisles is attached hereto and incorporated herewith as Exhibit D.

17 8. As of the date of this Declaration two Notices of Acknowledgment of Receipt have
18 been returned to our office bringing the number of unserved Cross-Defendants to 49.

19 9. As of the date of this Declaration, the unserved Cross-Defendants that were sent
20 notices and acknowledgments of receipt through this order to show cause proceeding have 20
21 days in which to return their signed notices. Two days were added to this date to accommodate
22 service via overnight delivery, making a response due on the 22nd day which for 49 packages
23 delivered on April 29, 2021 is Friday, May 21, 2021 and for the two delivered on May 3, 2021 is
24 Tuesday, May 25, 2021.

25 10. If further Notices and Acknowledgment of Receipts are received after the
26 Proposed Order is signed, the City shall remove those Cross-Defendants prior to publication.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct, and that this declaration was executed on May 5, 2021, at Stockton, California.



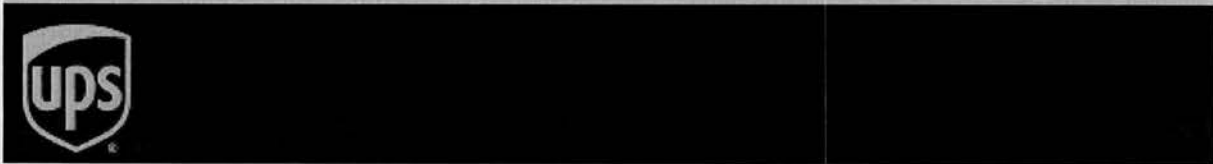

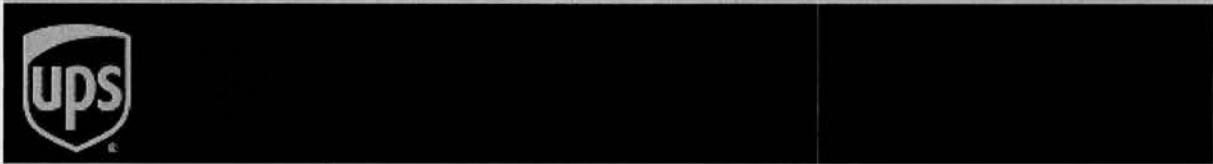
