2 On September 28, 2022, the parties appeared at (1) a hearing on Defendant and Cross-
3 Complainant City of San Buenaventura (“Ventura”) and Cross-Defendants Casitas Municipal
4 Water District, the City of Ojai, the East Ojai Group, Ventura River Water District, Meiners Oaks
5 Water District, and Matilija Mutual Water Company’s joint *ex parte* application for an order
6 continuing the stay in this action for six (6) months to March 30, 2023, also joined by the Wood-
7 Claeysens Foundation (“Ex Parte Request”) and (2) a further status conference, the Honorable
8 William F. Highberger, Judge presiding. The parties stated their appearances on the record and/or
9 they are reflected on LA Court Connect records. The Court made the following orders and
10 determinations:

- 11 1. The Court granted the unopposed Ex Parte Request, and the current stay of the
12 case for all purposes is extended for six months to March 30, 2023.

 - 19 b. Any objections to the [Proposed] Interim Order Confirming an Exempt
20 Cross-Defendant Class must be filed and served by 4:30 p.m. on
21 Wednesday, October 5, 2022.
- 22 3. The Court set a further status conference for December 6, 2022 at 10:30 a.m.
 - 23 a. A joint report, organized by Ventura, shall be filed by November 29, 2022.
